



### England signed bat giveaway – Terms and Conditions

1. These terms and conditions of entry, including information on how to participate and prize details (Terms) apply to the promotion, and entry is deemed acceptance of these terms.
2. The promoter is The Royal London Mutual Insurance Society Limited of 55 Gracechurch Street, London, EC3V 0RL (“Promoter”)
3. Entry: Entrants must be aged 16 or over. To enter this Prize Draw, entries must comply these Terms and Conditions and all other reasonable requests from time to time made by Promoter.

The draw will take place under the supervision of an independent observer. The full name of the independent person can be provided upon written request. Each winner will be notified within a reasonable time following the promotion. The prize is awarded conditionally upon acceptance of these Terms and Conditions. If a winner is unable to be contacted after a reasonable period or if any prize is unclaimed or declined within a reasonable period, the prize shall be deemed as unclaimed or unaccepted and an alternative winner may be drawn at Promoter’s discretion.
