



**TERMS AND CONDITIONS FOR ARMCHAIR PUNDIT 2018 CRICKET SOCIAL  
ACTIVATION PRIZE DRAW**

1. The “Promoter” is The Royal London Mutual Insurance Society Limited, a company incorporated in England and Wales (company number 99064) and having its registered office at 55 Gracechurch Street, London, EC3V 0RL.
2. By entering this prize draw (the “**draw**”) entrants agree to be bound by these terms and conditions and any other requirement set out in the material relating to this promotion.
3. This draw is only open to UK residents who are over the age of 18. Automated entries, bulk entries or third party entries will be disqualified.
4. Entrants must not be an employee or contractor of the Promoter or any subsidiary of the Promoter or be in any other way connected with this draw (including relatives of any such person).
5. Entry to the draw is free and there is no requirement to purchase any products from the Promoter.
6. Entries may be made by tweeting your commentary of the 2018 England men’s one-day internationals against Australia and India using the hashtag #ArmchairPundit on the following dates during the times specified in paragraphs 7 to 10 below. If you enter Prize draw 2 or 3 the Promoter will reply to your tweet and ask you to specify prize preference. If you provide a preference you will only be eligible to win that prize. If you do not specify a preference you will be eligible to win any of the tickets on offer as prizes, however winners will only be able to win one pair of tickets.

8. Prize draw 2 (Saturday 16 June 2018):
  - a. The prize draw shall open to new entries at 11:00 on Saturday 16 June 2018 and shall close to new entries when the one-day match has officially ended. The Promoter reserves the right to start and end draws on different dates and will advertise these dates on its website.
  - b. Four prize winners will each win a pair of tickets to the England men’s one-day international on Tuesday 19 June 2018.
  - c. Four prize winners will each win a pair of tickets to the England men’s one-day international on Thursday 21 June 2018.
  - d. Four prize winners will each win a pair of tickets to the England men’s one-day international on Sunday 24 June 2018.
9. Prize draw 3 (Sunday 24 June 2018):



- a. The prize draw shall open to new entries at 11:00 on Sunday 24 June 2018 and shall close to new entries when the one-day match has officially ended. The Promoter reserves the right to start and end draws on different dates and will advertise these dates on its website.
  - b. Four prize winners will each win one pair of tickets to the England men's one-day international on Tuesday 12 July 2018 and four prize winners will each win a pair of tickets to the England men's one –day international on Saturday 14 July 2018.
- 10. Prize draw 4 (Saturday 14 July 2018):**
- a. The prize draw shall open to new entries at 11:00 on Saturday 14 July 2018 and shall close to new entries when the one-day match has officially ended. The Promoter reserves the right to start and end draws on different dates and will advertise these dates on its website.
  - b. Four prize winners will each win a pair of tickets to the England men's one day international on Tuesday 17 July 2018.
- 11.** Statistical data collected from the entries submitted may be used in subsequent marketing material by the Promoter but will only be used on an anonymous basis (for the avoidance of doubt individual entrants or their company name will not be named, subject to clauses 15 and 16).
- 12.** The prize will be subject to such terms and conditions as may be imposed by the ultimate issuer of the prizes the Royal London Brand Team. The Promoter shall not be responsible or liable for any costs beyond the initial purchase price of the prizes.
- 13.** Prizes are allocated by the Promoter and the winner is not able to select the prize.
- 14.** The winners will be drawn at random after the closing time of each draw from the entries received for each prize draw, and these names shall be the winners of the prizes. For prize draw 2 there will be 3 separate draws so that the Promoter can take account of entrants who has specified a prize preference. For prize draw 3 there will be 2 separate draws so that the Promoter can take account of entrants who has specified a prize preference. Each draw will take place under the supervision of an independent observer. The full name of the independent person can be provided upon written request. Prizes are allocated by the Promoter and the winner is not able to change the prize.
- 15.** In the event of unforeseen circumstances making the administration of the competition impossible or impractical, the Promoter reserves the right to cancel any draw. In the event of such cancellation entrants shall be notified within 7 days of cancellation. Entrants will be notified of cancellation by notice being posted on the Royal London cricket website ([www.royallondoncricket.com](http://www.royallondoncricket.com)). The Promoter shall not be liable for any loss whatsoever as a result of cancellation of the draw.
- 16.** The Promoter reserves the right to vary the prize without prior notice to an alternative prize of equal or greater value. No cash alternative shall be available.
