TERMS AND CONDITIONS FOR ROYAL LONDON MOMENTS 2019 ACTIVATION BOOTH PRIZE DRAW

1. The “Promoter” is The Royal London Mutual Insurance Society Limited, a company incorporated in England and Wales (company number 99064) and having its registered office at 55 Gracechurch Street, London, EC3V 0RL.
2. By entering this prize draw (the “**draw**”) entrants agree to be bound by these terms and conditions and any other requirement set out in the material relating to this promotion.
3. This draw is only open to who are resident in the UK and over the age of 18 and attending a Royal London cricket match where the activation booth is present. Automated entries, bulk entries or third party entries will be disqualified.

5. The prize is an England 2019 ODI replica playing kit including:
 - a. England 2019 ODI replica playing short sleeve top
 - b. England 2019 ODI replica playing trousers
 - c. England 2019 ODI replica training long sleeve top

20. The Promoter reserves the right to vary the prize without prior notice to an alternative prize of equal or greater value. No cash alternative shall be available.

21. The Promoter reserves the right to refuse to award the prize to anyone in breach of these terms and conditions.



- 22.** The winners will be notified in writing no later than three days after the draw has taken place. The winners will be asked to provide an address for the prize to be sent to. The England 2019 ODI replica playing kit will be launched on 21st May 2019. The prize will need to be ordered and the winners will be notified of when they can expect to receive their prize by Royal London as soon as the order has been placed. Prizes will only be sent to a valid UK address unless otherwise stated.
